
Redeem invitation


Single sign-on

The majority of users will go through the following process.


From the login screen of My EY, click on "Sign in"




You will be prompted with a cookie statement. Please review and choose to accept, decline, or customize cookies. You can always change the options at any time within the My EY user site.




Next enter your email address, then click "Next".




You will be prompted to enter your password. This is your organizational password that is used to log in to your own system. Then click "Sign in".




Review the permissions and click either "Accept" or "Cancel". Please note that if you click "Cancel" you will not be able to move forward to log in to My EY or access EY products.




You may be prompted with a dialog box to select whether to remain signed in or not. You may choose "No", "Yes" and/or check the box that is labeled "Don't show this again".






One-time password


AuthO hosted username and password

Some users may be using an AuthO identity, either hosted by EY or your organization is federated with AuthO. Hosted identities will require you to create your own password for use to access My EY and EY products. Federated identities will use your own organizational credentials.


If you have a specific URL provided to you from your organization to access EY products, please use that link to log in.


You will see a message to let you know that you must change your password. Click "OK" to proceed.





External user account types

My EY modernizes the way that we manage external user identities by employing Microsoft Entra (Azure) B2B federation to connect EY with their organization. When these users join My EY, they will use their own organization's credentials to access our line of business products (e.g., EY Canvas Client Portal, EY Interact, and so on).

- Before using My EY, external users are required to complete a one-time registration process. To begin this process, an EY practitioner will invite them to join My EY.
- Some external users may also be required to use Multi-factor Authentication (MFA) when accessing specific line of business products.
- ▶ Depending on the external organization's MS Entra (Azure) capabilities, the external users will be given one of the identity types in the following table.

Account type	Sign in experience	Description	
MS Entra (Azure) managed tenant	Single sign-on	External users will be directed to their MS Entra (Azure) tenant to sign in. Their organization's security and password complexity rules are applied, which means that their organization controls how often their password expires and how complex the password should be.	
MS Entra (Azure) unmanaged tenant	Email one-time password (EOTP)	For external organizations that have an unmanaged MS Entra (Azure) tenant or do not have an MS Entra (Azure) tenant at all. These external users will log in with a six-digit code that is sent to their email address. They will receive a new code each time they begin a new session.	
Auth0 - hosted or federated	Username and password	For external users who cannot use their MS Entra (Azure) tenant (tenant restrictions, National/Sovereign Cloud clients are a few), we can establish the client's domain as an AuthO authenticated domain. AuthO federated users will use their organization's email address and password to authenticate. Hosted users would create their own passwords and maintain that password. Some products are not available for AuthO authentication.




Scrolling down the page you will see the help desk email address as well as local toll numbers. Currently, the help desk is an English-speaking service, except for the Greater China phone number and email address.
