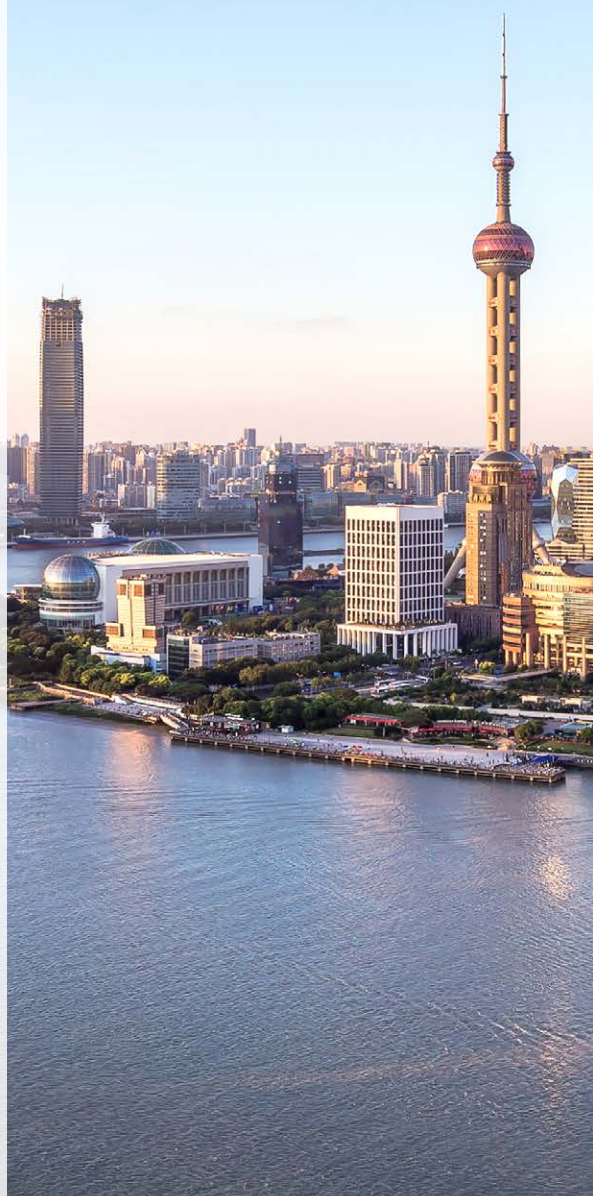

前言 Foreword

当前，百年变局加速演进，全球地缘政治经济格局变化交织，但无论如何，都未改变企业家作为全球经济发展关键力量的时代地位。伴随着新一轮科技革命和产业变革深入发展，中国企业家精神的内涵在国家富强、民族复兴的进程中加速重构，朝着更加重视时代使命、服务高质量发展的方向稳步前行。

The WEOY is held annually. A diverse panel of independent judges assesses the achievements of nearly 50 overall program winners from around the world and selects one winner. Cho Tak Wong of Fuyao Glass Industry Group, the EOY 2008 Chinese mainland winner, went on to be named WEOY 2009.

On this occasion, the world's leading entrepreneurs come together to forge invaluable connections across industries, geographies and passions; attend workshops hosted by the most sought-after thought leaders; and celebrate the enduring impact of entrepreneurship.

被提名人必须为企业的所有者或管理者，对企业近期业绩负主要责任，被提名人所在的企业必须成立两年或以上。

How to apply

To be eligible to enter the program, the nominee must be an owner or the manager primarily responsible for the recent performance of the company. The nominee's company must be at least two years old.

Anyone associated with a successful entrepreneur - professional advisor, customer, supplier, banker, lawyer, employee or spouse - may nominate the individual. Entrepreneurs can also nominate themselves. All information submitted on the nomination form will be kept strictly confidential and will only be used by EY and an independent panel of judges for the selection process. Only the winners selected by the panel will be announced to the public. A nomination form is attached to the last page of this brochure. It can also be downloaded at ey.com/en_cn/entrepreneur-of-the-year-program.

How the winners are chosen

After the nominations are received, they are thoroughly screened and evaluated based on the information provided in the nomination form. We then meet with each candidate for due diligence interviews and prepare evaluation reports for judges' deliberation.

The independent judging panel decides on the winners after undertaking a rigorous selection process.

Each annual program concludes with a competition and announcement of category winners - such as industry and innovation winners - and an overall winner.

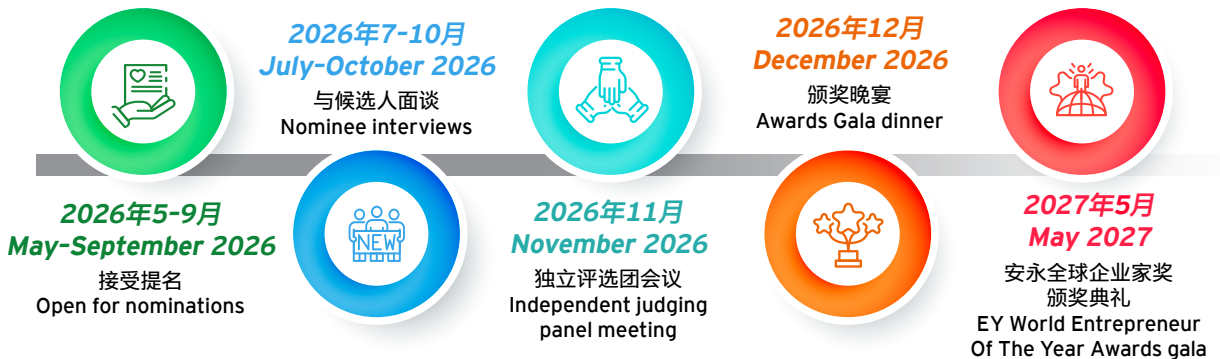
