Update on OA 395

We are writing to provide an update in relation to OA 395, which was the Company's application to the Singapore High Court for permission to commence judicial review in relation to certain orders made by the Commercial Affairs Department and the Singapore Police Force (collectively, the "**Authorities**").

The Company and the Authorities have since resolved the subject matter of OA 395, and OA 395 was discontinued on 21 November 2022 (by way of the Order of Court, HC/ORC 5875/2022 (the "Order")). In this regard, the Authorities will be making the necessary applications to Court for the release and disposal of the cryptocurrency previously seized and/or frozen by the Authorities.

We will provide a further update at the appropriate juncture.
