**Extension of Deadline to Creditors of the Company to File Proof of Debt (“POD”) For the Purpose of Voting**

Dear Sir / Madam,

We refer to the subject matter, the 33<sup>rd</sup> Circular issued by the Liquidators on 28 May 2025 and the 36<sup>th</sup> Circular issued by the Liquidators on 13 June 2025. Unless otherwise stated, we adopt the abbreviations used therein.

The Liquidators have continued to receive queries from creditors regarding the steps required to file their PODs and will endeavor to respond to all queries as soon as possible. Nonetheless, the Liquidators appreciate that this may impact the creditors’ ability to meet the Voting Claims Deadline of 19 June 2025. In view of this, the Liquidators will be extending the Voting Claims Deadline to **3 July 2025**. As such, any creditors who wish to attend and vote at the First Meeting and who have not already done so should complete and submit their PODs along with all supporting documents to the Liquidators, **by 3 July 2025**.
