URGENT UPDATE REGARDING FRAUDULENT / SUSPICIOUS EMAIL PURPORTING TO BE
FROM THE LIQUIDATORS OF THE COMPANY**

Dear Sir / Madam,

We refer to the subject matter.

It has come to the Liquidators' attention that certain creditors and / or users may have received an email from the email address “help@hodlnaut-mail.com” with the subject line “**Notice: Updated Terms of Service Require Acceptance**”.

The email purports to have been issued in connection with the ongoing administration of the Company and states, among other things, that the Liquidators have directed revised service terms to be issued to creditors and account holders. The email further states that account holders are required to review and accept an updated agreement within 7 business days in order to maintain their standing in the distribution process, failing which their distribution may be placed on hold.

We wish to inform all creditors and users that the above email was **not** issued by the Liquidators and was **not** sent on behalf of the Company or the Liquidators. The Liquidators have not directed any revised service terms to be issued to creditors or account holders, and creditors are not required to accept any updated terms of service in order to maintain their standing in the distribution process.

For the avoidance of doubt, the Liquidators do not own or maintain the email address “help@hodlnaut-mail.com” or any similar email address.

Creditors and users should not click on any links, respond to the email, provide any personal information, account credentials, banking details, wallet information, or take any action in response to the above email.

The Liquidators are looking into the matter and reserve all rights to take such steps as may be necessary, including making the relevant reports to the appropriate authorities.
