We refer to the Third Circular dated 19 September 2022, the Sixth Circular dated 2 October 2022, the Fifteenth Circular dated 10 November 2022 and the Eighteenth Circular dated 25 November 2022.

Update on Case Conference in relation to OA 451 on 29 November 2022

We are writing to provide an update on the Case Conference held before the learned Assistant Registrar Karen Tan on 29 November 2022 pertaining to OA 451 (*i.e.*, the Company’s application for Judicial Management).

Please be informed that the Court has made the following directions during the Case Conference:

- A further case conference is fixed for 10am on Thursday, 29 December 2022 for OA 451 and HC/SUM 3660/2022;
- The Interim Judicial Managers (the “**IJMs**”) are to write to the Court by 20 December 2022 to confirm that the IJMs’ Supplementary Report has been filed, and that the responsive affidavit of the Company (if any) has been filed;
- The Company is to inform the IJMs if the Applicant does not intend to file the aforementioned Applicant’s responsive affidavit; and
- Once the IJMs have provided confirmation as set out above, the case conference fixed for 10am on Thursday, 29 December 2022, will be vacated.

Administrative Update on the JM Hearing

As stated in the Sixth Circular, the hearing for OA 451 has been fixed for 10am, on 13 January 2023 (the “**JM Hearing**”). The Court has clarified that the JM Hearing will be held via Zoom.
