**Updates in relation to HC/SUM 1537/2023 (“SUM 1537”) and HC/CWU 94/2023 (“CWU 94”)**

Dear Sir/ Madam

We refer to the Thirty-Fourth Circular dated 25 April 2023.

As mentioned in the Thirty-Fourth Circular, the Court directed for the IJMs to proceed to file a petition to wind-up the Company with a concurrent application to discharge themselves as the IJMs.

We write to update that on 22 May 2023, the IJMs have filed SUM 1537, *i.e.*, the application to discharge the IJMs (the “**Discharge Application**”), and CWU 94, *i.e.*, the application to wind up the Company (the “**Winding-Up Application**”).
