Arrival UK Ltd (in Administration) ('the Company')

The Administration of the Company was due to end on 4 February 2026.

Pursuant to paragraph 76 of Schedule B1 of the Insolvency Act 1986, the Administration has now been extended to 4 August 2026, by order of the County Court. I enclose formal notice of the extension, for your information.

Additionally, pursuant to Paragraph 98(2) of Schedule (B1) of the Insolvency Act 1986, a conditional discharge order was granted by the Court for Alan Hudson's, Sam Woodward's and my discharge from liability as Joint Administrators. The discharge is conditional to the completion of the IP Sales Process and the declaration of any final dividend distributions to preferential creditors being completed by 28 February 2026.

The Joint Administrators' discharge from office will be effective from 28 days after the date on which the notice filed by the Joint Administrators to bring the Administration to a close and move the Company to dissolution is registered by the Registrar of Companies.

A further update will be provided in my next report to creditors, for the period ending 4 February 2026.
