## HFL Realisations Limited (formerly House of Fraser Limited) (in Administration) ("the Company")

As you are aware, on 10 August 2018, the Company entered administration and A M Hudson, R H Kelly, C P Dempster and C A Lewis were appointed as Joint Administrators.

As creditors may recall, following creditors' consent being obtained in terms of paragraph 76(2)(b) of Schedule B1 of the Insolvency Act 1986, the period of the Administration was extended by 12 months to 10 August 2020. Following an application to the Court of Session under paragraph 76(2)(a) of Schedule B1 of the Insolvency Act 1986, a further extension was made by 12 months to 10 August 2021.

We currently anticipate that we will require to apply to the Court of Session to further extend the period of the Administration by 18 months to 10 February 2023 to allow time to:

- Continue to collect ongoing rates refunds for the benefit of creditors;
- Agree unsecured creditor claims and distribute the prescribed part to the agreed unsecured creditors.
