Dear Direct Scheme Creditor

CX Reinsurance Company Limited (in Administration) ('the Company' or 'CX Re')

RE: Proposed Scheme of Arrangement pursuant to Part 26 of the Companies Act 2006 between the Company and its creditors in respect of policies of direct insurance (the "Direct Scheme")

As described in the Practice Statement Letter dated 4 September 2024, the Company applied to the High Court of Justice, Business and Property Courts of England and Wales, Insolvency and Companies Court (Chancery Division) for permission to convene a meeting of Direct Scheme Creditors (the "Direct Scheme Meeting") to consider a proposed scheme of arrangement pursuant to Part 26 of the Companies Act 2006 (the "Direct Scheme"). The hearing relating to this application (the "Convening Hearing") took place on 3 October 2024. We are pleased to confirm that, by way of an order dated 4 October 2024, the Court granted the Company's request to convene the Direct Scheme Meeting.

We attach a copy of the document (the "Direct Scheme Document") containing:

- 1. a statement explaining the terms of the Direct Scheme (see Section I);
- 2. the terms of the Direct Scheme (see Section II);
- 3. a notice confirming the date and time of the Direct Scheme Meeting (see Schedule 3, at pages 112 113); and
- 4. a voting and proxy form for completion and submission by no later than 5.00pm (London time) on 11 December 2024 to be used for the purpose of voting at the Direct Scheme Meeting (see Schedule 4, at pages 114 130)

The Direct Scheme Meeting will take place remotely on 12 December 2024 at 5.00pm (London time) through the web-based platform web.lumiconnect.com. Direct Scheme Creditors may attend by logging in using the URL and unique login credentials ("Access Details") provided to them below.

Please note that a Direct Scheme Creditor wishing to attend the Direct Scheme Meeting must submit a valid voting and proxy form to the Company by 5.00pm (London time) on 11 December 2024. Incomplete or late voting and proxy forms may not be accepted for voting purposes.

Lumi will provide a secure online platform for the Direct Scheme Meeting. This will allow you to participate in the Direct Scheme Meeting remotely. A facility to vote and ask questions in real time during the Direct Scheme Meeting will be available.

For optimum performance, it is suggested that you use the latest version of the Google Chrome browser on a laptop or personal computer. However, other browsers can also be used. Please ensure that you have a high quality and reliable internet connection.

The username and password are unique to you. Please do not share these details with anyone else. You should confirm the name(s) and contact details of your attendee(s) on your voting and proxy form. Attendees who have not been notified to the Company in advance of the Direct Scheme Meeting may not be permitted entry. It is recommended that you login at least 10 minutes before the scheduled start of the Direct Scheme Meeting.

Voting

The resolution and voting choices will automatically appear on the online Lumi platform when the Chairman declares the vote open. To cast your vote, simply click one of the options shown on screen. There is no submit button.

Once your vote is cast, your chosen option will be highlighted, and a confirmation message will appear to show that your vote has been received. You can change or withdraw your vote at any time until the Chairman declares the voting closed.

Questions

Questions from Direct Scheme Creditors and their proxies will be addressed during the "question and answer" section of the Direct Scheme Meeting.

Written questions can be submitted at any point during the Direct Scheme Meeting by clicking the messaging icon in the navigation bar and typing your question into the "Ask a question" box. Verbal questions, comments or observations can be submitted by clicking the "Request to speak" button (which will become available at the bottom of the broadcast window when the Chairman invites questions) and following the on-screen instructions to join the queue to speak.
