I refer to my appointment as a Former Joint Administrator of the Company.

The Former Joint Administrators intend to make an application to Court for an Order pursuant to paragraph 98(2)(c) of Schedule B1 to the Insolvency Act 1986 that they be discharged from liability in respect of any action of them as administrators of the Company ("Application").

The Former Joint Administrators intend to request that such discharge from liability becomes effective on the date which falls 28 days after the date the Court Order is uploaded to the creditors' portal save in respect of any claims notified to the Former Joint Administrators prior to that date.

I am therefore writing to you to advise that the Application is in the process of being prepared and will shortly be presented to the High Court of Justice, Business and Property Courts of England and Wales.
