## Extraspace Solutions (UK) Limited (in Administration) ('the Company')

The affairs, business and property of the Company are being managed by the Joint Administrators, who act as agents of the Company only and without personal liability.

The Company is being wound down under our supervision whilst we conduct an investigation of its financial affairs.
