HF Stores Realisations Limited (formerly House of Fraser (Stores) Limited) (in Administration) ("the Company") Court of Session, Number P794/18 Registered office address: c/o Ernst & Young LLP, Atria One, 144 Morrison Street, Edinburgh, EH3 8EX

I write, in accordance with Rule 3.93 of the Insolvency (Scotland) (Company Voluntary Arrangements and Administration Rules 2018), to provide creditors with a report on the progress of the administration. This report covers the period from 10 August 2024 to 9 February 2025 ("the Period") and should be read in conjunction with our previous reports dated 4 September 2024, 11 March 2024, 12 September 2023, 21 March 2023, 7 September 2022, 21 March 2022, 15 September 2021, 22 March 2021, 17 September 2020, 19 March 2020, 20 September 2019 and 6 March 2019. Statutory information about the Company, the administration and the office holders is given at Appendix 1

The Company, registered number SC010677, entered administration on 10 August 2018 ('the Date of Appointment') and A M Hudson, R H Kelly, C P Dempster and I were appointed to act as Joint Administrators ('Joint Administrators'). The appointment was made by The Court of Session under the provisions of paragraph 12 of Schedule B1 to the Insolvency Act 1986. Under the terms of the appointment, any act required or authorised to be done by the Joint Administrators can be done by any one of them.

R H Kelly and C P Dempster resigned as Administrators of the Company on account of their retirement as Partners of EY. Mr Kelly's resignation took effect on 29 June 2022 and Mr Dempster's resignation took effect on 24 November 2023.

Summary of progress since last report

Extension of the Administration

The Joint Administrators sought consent of the secured and preferential creditors, under paragraph 78(2) of Schedule B1 to the Insolvency Act 1986, to extend the period of the administration by a period of twelve months, ending on 10 August 2020. A second extension was sought via an application to the Court of Session to extend the period of the administration by twelve months to 10 August 2021. A third extension was sought via an application to the Edinburgh Court to extend the administration for the period of eighteen months ending on 10 February 2023, which was granted on 28 July 2021. A fourth extension was sought via an application to the Court of Session to extend the administration for the period of twelve months ending on 10 February 2024, which was granted on 6 February 2023.



A fifth and final extension was sought via an application to the Court of Session to extend the administration for the period of twelve months ending on 10 February 2025, which was granted on 8 February 2024.

No further extensions were sought and the administration was concluded on 10 February 2025.

Debtors

Total collections from trade and other debtors in the Period totalled £1,729.26, resulting in total collections up to the date of this report of £2,321,800.79.

During the Period £1,729.26 has been received directly to the Company's post administration bank account from HM Courts and Tribunals Services ("HMCTS") in respect of 155 payments. Any further monies due to the Company from HMCTS following the conclusion of the administration will be paid directly to the Security Agent on behalf of the Secured Creditors. We have advised HMCTS of this position to enable any future payments due to the Company from HMCTS to be paid directly to the Security Agent.

Intercompany debtors

The Company had lodged an unsecured claim of £205,279,147.36, which ranked for dividend purposes, in the liquidation of House of Fraser (Funding) Plc ("Funding"). A first and final dividend of 0.00003p (rounded down) in the £ was declared and paid by Funding on 15 January 2025, and a payment of £6,488.82 was received by the Company, on the same date, in this regard.

Rates refunds

As previously reported, Montagu Evans LLP has been instructed on a success fee basis to appeal the rateable values across a number of properties within the portfolio. In the Period, no additional funds were received and no further recoveries are expected. Total recoveries from this source to date are £3,063,042.80.

Purchaser payments

During the administration a number of invoices were paid by the Company and subsequently recharged to the Purchaser, including the amounts outlined below:

- 1. Property insurance, including property damage, business interruption and terrorism insurance in the sum of £88,241.83 was recharged to the Purchaser and payment received in the Period;
- 2. An invoice was paid pre appointment by the Company for a premium in relation to The House of Fraser Non-Registered Group Life Scheme and Assurance Scheme with Canada Life and a total amount of £84,695.18 was apportioned to be paid by the Purchaser for the period 10 August 2018 to 31 March 2019. This amount was settled by the Purchaser during the Period.

Invoices were also raised, to be settled the Purchaser, which included an agreed contribution of £10,000 plus VAT towards the costs incurred in the extensions of the administration and an invoice of £30,000 plus VAT for an agreed contribution towards the costs incurred by the Joint Administrators in obtaining the Irish tax refund. These invoices have been settled by the Purchaser during the Period.



Remaining assets

A PAYE refund was due from the Irish tax authorities in the total sum of €90,915.45 and this refund has been chased by the Joint Administrators over the past eighteen months. However, to date, this refund has not been received from the Irish tax authorities and a decision has been taken by the Joint Administrators, in conjunction with the Security Agent acting for the Secured Creditors, to not request a further extension of the administration and this refund will be written off.

There are no further assets to pursue in respect of the Company.

Leasehold properties

As previously reported, at the Date of Appointment, the Company operated from sixty-four locations, all of which were occupied via leases, some of which were under subleases granted by other group companies. These sixty-four locations included fifty-nine trading stores, three office buildings and two warehousing facilities. As part of the sale, a licence to occupy all of the Company's premises (other than the HOF store in Dundrum) was granted to SDI (Propco 35) Limited ("the Property Purchaser").

The licence to occupy has been extended a number of times and expired on 31 March 2020, and, we understand that the Purchaser no longer occupies any of the sites. In respect of the sixty-four locations, fifty-two have been either surrendered or being treated as at an end to allow for the Purchaser to enter into new agreements with the landlord; two have been assigned to the Purchaser and ten have been vacated with the keys returned to the landlord (a number of which were later formally surrendered).

In addition to the sites noted above, the Company was also party to a small number of other ancillary property leases which the Company now has no further interest in.

Retention of title claims

The Joint Administrators have supported the Purchaser in dealing with the retentions of title claims and we believe these have all been concluded.

Creditors

The Joint Administrators and their staff verified the received unsecured claims during a prior period in readiness for a distribution via the prescribed part, further details of which are set out later in this report.

VAT

The Joint Administrators have submitted both VAT returns for the periods 1 June 2024 to 31 August 2024 and 1 September 2024 to 30 November 2024. The VAT refunds for the periods to 31 May 2024 and 31 August 2024, totalling £1,364.92 and £395.71 respectively, were received during the Period.

In preparation for the end of the administration of the Company, the Joint Administrators arranged for the Company to be deregistered for VAT purposes effective from 30 November 2024, in line with the final submitted VAT return. However, HMRC advised that deregistration was effective on 12 December 2024, resulting in the requirement for a further and final VAT return to be submitted for the period 1 December 2024 to 11 December 2024. A nil return has been submitted for the final period. HMRC have not raised any enquiries and so we consider this matter to be concluded.



During the period from 12 December 2024 to 17 January 2025, input VAT incurred on the Joint Administrators' penultimate fee amounting to £40,995.67. The Company reclaimed this amount in full from HMRC which was received on 23 January 2025. A further VAT reclaim was submitted for the input VAT incurred on the Joint Administrators' final fee and the final costs and expenses of the administration on 7 February 2025 for £42,719.85. In anticipation that the final VAT refund would not be received prior to 10 February 2025, a Deed of Assignment ("the Deed") has been agreed with HMRC, by which the final VAT refund will be paid directly to EY to settle the outstanding element of their final fee invoice.

During the Period, a final VAT refund from the Irish Revenue Authorities was received, totalling €13.576.00.

Corporation tax

We have instructed EY tax specialists to prepare the Corporation tax returns for the Company.

Corporation tax returns for the periods up to 10 August 2023, 10 August 2024 and 16 January 2025 have been submitted, which HMRC have not raised an enquiry into to date. The standard enquiry window is generally within 12 months from the filing date.

The standard enquiry window for the period ending 10 August 2022 has now closed and the standard enquiry window for the periods ending 10 August 2023, 10 August 2024 and 16 January 2025 closes on 10 August 2025, 10 August 2026 and 16 January 2027 respectively. However, the corporation tax returns that have been submitted show a position of nil tax due to HMRC due to previous trading losses.

During the Period, the Joint Administrators received a notice from HMRC detailing a tax late filing penalty payable by the Company of £100, which arose in respect of the Corporation tax return for the period ended 10 August 2023. The penalty was settled by the Company's Tax Advisors on behalf of the Company, however, HMRC advised that this penalty was also netted off against the VAT receivable balance on the VAT return for the quarter ended May 2024, resulting in the penalty being paid twice to HMRC. In order to rectify the double payment, the Joint Administrators included wording in the Deed requesting that £100 be repaid to EY on behalf of the Company.

As detailed in an above section of this report, the Company's remaining funds held on interest-bearing were removed effective from 16 January 2025. As such, it is our understanding that no further taxable income will be received in respect of the Company, resulting in there being no requirement for further Corporation tax returns to be submitted.

All tax work has been concluded, and all Corporation tax and other tax related time costs are included within the Joint Administrators' total time costs, set out in detail at Appendix 3.

Bank interest received / charges paid

Cash balances were held on deposit where positive interest rates were provided by UK clearing banks, and during the Period, fixed charge bank interest of £8,022.29 and floating charge bank interest of £64,509.59 have been received. Bank interest of \$6,468.61 was received into the Company's USD account.

Total bank interest received in the Company's GBP and USD accounts during the administration totalled £635,738.99 and \$20,333.13 respectively.



Bank charges in the sum of £2,638.35 were paid during the Period, however bank charges were also refunded in the period in the sum of £4,479.09 as these had been paid in error.

Investigations

There were no investigations ongoing or concluded in the Period and no further investigations to be undertaken.

Distributions to creditors

Secured creditors

On entering administration, the House of Fraser Group's secured funding could be analysed into three categories:

- Super senior secured working capital facility ("Super senior facilities").
- Senior secured revolving credit facility, senior overdraft and senior secured term loan lenders ("Senior facilities").
- ▶ Holders of senior secured floating rate notes, due 2020 ("Bondholders").

The table below summarises the facilities provided:

Other than the Super senior facility, which has priority ranking, the Senior facilities and Bondholders indebtedness ranks pari passu with each other.

The Joint Administrators made a first floating charge distribution to secured creditors of £60m on 12 October 2018, followed by a second floating charge distribution of £18.5m on 17 December 2018 and a third distribution of £5m on 29 August 2019. A first distribution to secured creditors under the fixed charge of £1.5m took place on 17 December 2018. A further floating charge distribution of £6m was distributed on 18 May 2021.

The confirmed indebtedness arising from these facilities at the Date of Appointment of the Joint Administrators, in particular the usage of the senior revolving credit facility and any post appointment interest and charges, is still subject to final confirmation.

The former Joint Liquidators of House of Fraser (UK & Ireland) Acquisitions Limited (formerly in Creditors' Voluntary Liquidation) ("Acquisitions") made a first and final distribution to secured creditors of £135,519.30 on 14 January 2025. This amount has been held on account by the Company, to be subsequently paid to the secured creditor at the conclusion of the administration of the Company.



The former Joint Liquidators of Funding made a first and final distribution to secured creditors of £10,955.45 on 15 January 2025. This amount has been held on account by the Company, to be subsequently paid to the secured creditor at the conclusion of the administration of the Company.

The Joint Administrators made a fourth and final distribution to secured creditors of £5,904,353.49 in the subsequent Period. This distribution included; the remaining funds in the estate of the Company, totalling £5,525,842.00, further to the settlement of all of the administration's liabilities as detailed above; a combined amount of £146,474.75 from Funding and Acquisitions; and £232,036.74 from HFL Realisations Limited (formerly in Administration) in respect of the first and final floating charge distribution to secured creditors made by that company.

Preferential creditors

All of the employees of the Company were transferred to the Sports Direct Group as a result of the sale of business. However, certain former employees have preferential claims in respect of arrears of wages, holiday pay and employee pension deductions.

Total preferential claims paid to date amount to £76,664.05.

As previously reported, five of the cheques, amounting to £339.53, which were initially issued to former employees with preferential claims in the administration were cancelled as they had not been cashed. These funds were paid to the Accountant in Bankruptcy ("AiB") in the Period.

No further preferential claims were received in the Period.

Non-preferential creditors

Based on the Company's Statement of Affairs filed with the Registrar of Companies it was estimated that non-preferential claims against the Company are c.£313.4m. However, claims received totalled £465,903,856.91.

The Prescribed Part

The Prescribed Part is a proportion of floating charge assets set aside for unsecured creditors pursuant to section 176A of the Act. The Prescribed Part applies to floating charges created on or after 15 September 2003.

Prior to the Joint Administrators making a dividend under the Prescribed Part, the Joint Administrators calculated, to the best of their knowledge and belief, that:

- The value of the net property as at the 29 July 2022 was £96.1m.
- The value of the Prescribed Part was £0.6m, being the amount available to be set aside, before the costs of dealing with the Prescribed Part.

In line with Rule 3.108 of the Insolvency (Scotland) (Company Voluntary Arrangements and Administration) Rules 2018, a list of all claims accepted and rejected in the administration is available for viewing at https://www.ey.com/en_uk/ey-house-of-fraser-administration. A hard copy of the list can be provided on request.



The Joint Administrators paid a first and final dividend under the Prescribed Part on 9 August 2022 to creditors of the Company whose claims have been accepted. The dividend was 0.139314581 pence in the £ on total accepted claims of £358,899,977.99.

In the previous reporting period, 542 of the cheques issued to unsecured creditors on 9 August 2022 were cancelled as they were yet to be cashed, total value of these cheques was £26,495.31. It is customary for companies in administration that the value of any unclaimed dividends to unsecured creditors of the Company be paid to the AiB prior to the Joint Administrators' release. Those unsecured creditors with an unclaimed dividend value greater than £1,000 were given a final chance to receive the value of their dividend. As a result, during the Period, the sum of £5,556.65 was paid out, as re-issued dividends, to unsecured creditors in respect of the Prescribed Part.

The remaining balance of £21,278.19 and the value held in the Company's Dissenting Shareholders account of £503.15 has been paid to the AiB during the Period, including a fee of £40 to make these payments.

Receipts and payments account

I enclose at Appendix 2 a receipts and payments account for the period from 10 August 2024 to 9 February 2025.

Joint administrators' remuneration

The statutory provisions relating to remuneration are set out in Rules 3.95 to 3.101 of the Insolvency (Scotland) (Company Voluntary Arrangements and Administration) Rules 2018.

In certain circumstances, creditors are entitled to request further information about our remuneration or outlays, or to apply to court if they consider the costs to be excessive (Rule 3.100, Insolvency (Scotland) (Company Voluntary Arrangements and Administration) Rules 2018. Further information is given in 'A Creditors' Guide to Administrators' Fees', a copy of which may be accessed from the web site of the Institute of Chartered Accountants of Scotland at https://www.icas.com/technical-resources/creditor-guides-to-office-holder-remuneration or is available in hard copy upon written request to the Joint Administrators.

Our remuneration was fixed on a time-cost basis by a resolution of the secured creditor and the preferential creditors on 29 March 2019.

The Joint Administrators have incurred time costs of £161,743.00 in the Period and a total of £10,682,355.21 to date, against which £3.46m plus VAT has been drawn. Appendix 3 of this report provides an analysis of the time spent. The work completed in the Period includes the following:

- Statutory reporting including progress reports to creditors;
- Correspondence with creditors, including re issue of distribution payments, following payment of the prescribed part distribution;
- Recovery of the Irish VAT refund and pursuing the Irish PAYE refund;
- Preparation and submission of VAT returns;
- Preparation and submission of Corporation Tax returns;



Maintaining the bank account and recording receipts; making payments; bank reconciliations.

On 24 November 2022, £100,000 plus VAT was drawn in respect of time costs incurred in relation to the Prescribed Part distribution. This is shown within the prescribed part dividend in our receipts and payments account.

During the Period, the Joint Administrators raised and settled total fees in the amount of £200,000, plus VAT.

The Joint Administrators have incurred disbursements of £41.50 in the Period and a total of £69,201.31 of disbursements to date, against which £4,978.35 was settled in the Period, and a total of £50,572.11 plus VAT has been paid to date. An analysis of Category 2 disbursements (i.e. charges made by the office holders' firm that include elements of shared or overhead costs) are set out in Appendix 4 of this report.

Of the total disbursements, €22,000.00 was in relation to fees paid to our Irish Tax Team for their time-costs incurred finalising the Company's tax position in Ireland. These costs have not been included in Appendix 4, as they were met by the Purchaser, rather than from the estate.

Joint administrators' outlays

We have incurred outlays of £41.50 during the Period in respect of printing costs. There is an analysis of outlays incurred to date at Appendix 4 of this report.

Pre-administration costs

As per the report dated 20 September 2019, we received approval from the creditors and settled payment of pre-administration costs totalling £728,841.39 plus VAT for fees, together with expenses of £15,147.82 plus VAT.

Joint Liquidators' Fees

The Joint Liquidators of House of Fraser (PIH) Limited, House of Fraser (Finance) Limited and House of Fraser (Stores Management) Limited had agreed with Security Agent for the Secured Creditor of the Company that fees in the sum of £10,500 plus VAT, £5,000 plus VAT and £17,500 plus VAT respectively could be raised and subsequently settled by the Company. On this basis total payments of £43,500 have been settled by the Company during the Period. This resulted in a recovery of £146,474.75 for the benefit of the Secured Creditors.

The outcome of the administration

The purpose of the administration has been sufficiently achieved and the administration came to an automatic end in the subsequent Period through expiry of time.

All matters of the administration have now been concluded and the Joint Administrators have submitted their final receipts and payments account together with relevant forms to Companies House.

Time charging policy

The Administrators have engaged managers and other staff to work on the Administration. The work required is delegated to the most appropriate level of staff taking account of the nature of the work and the individual's experience. Additional assistance is provided by accounting and treasury executives dealing with the company's bank accounts and statutory compliance diaries. Work carried out by all staff is subject to the overall supervision of the Administrators.

All time spent by staff working directly on case-related matters is charged to a time code established for the case. Time is recorded in units of six minutes. Each member of staff has a specific hourly rate, which is subject to change over time. The average hourly rate for each category of staff over the period is shown below, as are the current hourly rates used.
