## Key dates for the 2026 program

- **December 1, 2025: Applications open**
- **February 27: Application deadline**

- **June 12:** Florida awards celebration
- **Early fall:** Florida alumni receptions

## Eligibility requirements

### The entrepreneur

- The entrepreneur must be the CEO or president of a private or public company who is primarily responsible for the recent performance of the company.
- The entrepreneur may be the original founder, a multigenerational family business leader, or a transformational CEO who is not the founder of a company or subsidiary.
- The entrepreneur must have been in the role for at least two years by the application deadline.
- Previous finalists and applicants who did not win are eligible to reapply.
- Former award winners may reapply if they have founded or transitioned to a new company.

### The company

- The company must have been in business for at least two years by the application deadline.
- The company must have a minimum revenue of \$10m.\*
- Only for-profit businesses based in the US may apply.

*\* Potential exceptions to the minimum revenue requirement include pre-revenue companies in the Life Sciences sector, as well as emerging high-growth companies that are less than five years old.*
