

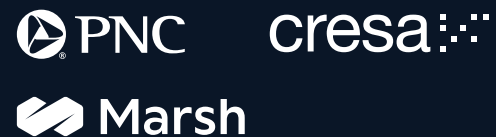

Judging criteria

The independent panel of judges is a collective of proven leaders. Many are past winners and esteemed alumni of the program, embodying the pinnacle of entrepreneurial success.

Judges evaluate nominees on a variety of criteria, including, but not limited to:

- Entrepreneurial spirit
- Growth
- Financial performance
- Purpose
- Impact

Eligibility requirements

The entrepreneur

- The entrepreneur must be the CEO or president of a private or public company who is primarily responsible for the recent performance of the company.
- The entrepreneur may be the original founder, a multigenerational family business leader, or a transformational CEO who is not the founder of a company or subsidiary.
- The entrepreneur must have been in the role for at least two years by the application deadline.
- Previous finalists and applicants who did not win are eligible to reapply.
- Former award winners may reapply if they have founded or transitioned to a new company.

The company

- The company must have been in business for at least two years by the application deadline.
- Companies are most competitive when they demonstrate long-term value.
- Only for-profit businesses may apply.
