- ▶ All sensitive information is stored on servers using enhanced data security standards and multifactor authentication.

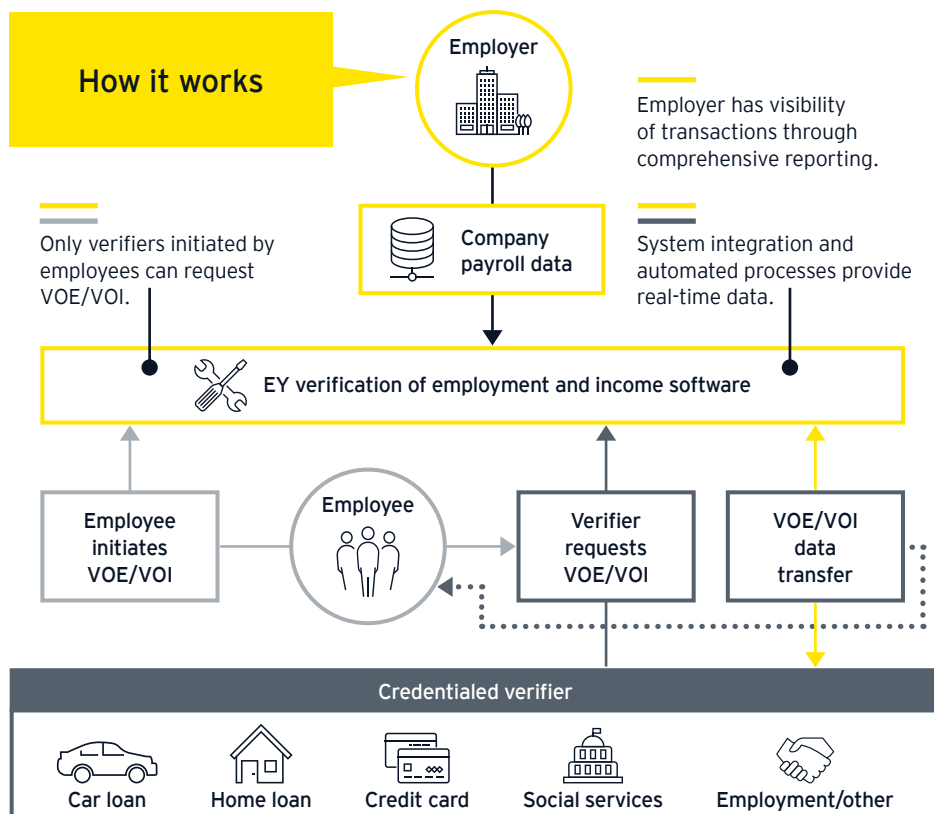
