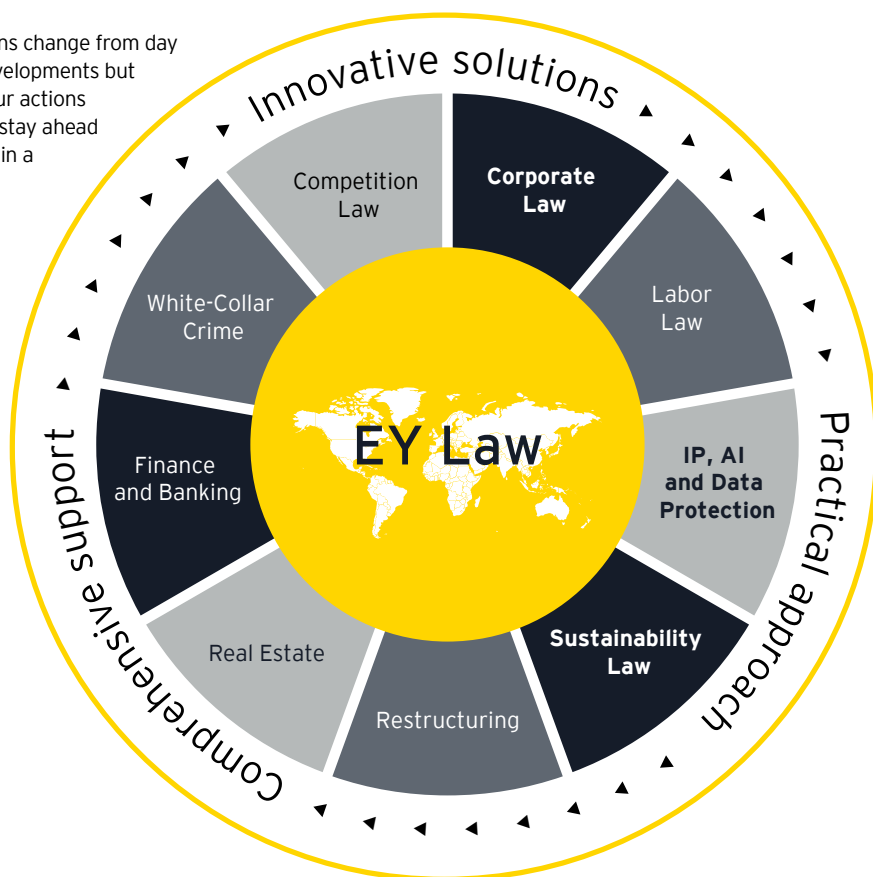

Corporate and commercial law

Ongoing corporate advice, including:

- Corporate governance matters, such as preparing regulations for company bodies, internal policies, etc.
- Support in drafting resolutions of company bodies (supervisory board meetings, management board meetings, general meetings), preparing legal opinions, etc.
- Automated (also using AI tools) handling of meetings and sessions of company bodies, including preparing resolutions, minutes, notifications, applications, etc., for all companies within the capital group.

Mergers and Acquisitions (M&A)
